1. Opening

3. Update on the Indianapolis Plan

4. Senior Pastor/Administration - Pastor Darren

6. Committee Reports -

Finance - John Drake (Finance) and Marie Lang (Finance Director)

- Marie and John presented financial reports for the period ending July 31, 2019.*
- Marie and John report that all bank accounts had been reconciled, current bills are paid, and income received has been posted.
- Discussion occurred regarding how prepaid income was currently treated on an accrual basis when it seemed a cash basis might be more appropriate for the church. Marie and John were going to evaluate this further and advise the board later if they were going to suggest a change to our accounting method.
- The budgeting process for 2020 Has begun, and Marie was working with staff members.
- The annual financial audit has begun, and although the auditors had some questions, there was no great concern.
- Marie asked for authorization to consolidate and merge all three checking accounts into one. The request was approved unanimously.

- Jeff asked if the trustees needed to have projects and the finances approved by the Board of Directors. The boards' response was "NO" if the Trustee's budget was being utilized. - Jeff advised the following projects are under consideration:
 - Exterior signage still in progress,
 - Restroom, Parlor, & Conference Room updates;
 - Mechanical, Electrical, & Plumbing contractors on board, proceeding with plans;
 - HVAC for Darren and Nancy getting a quote;
 - Invasive species report received, will send to the Board;
 - Masonry, may not be an exterior issue, pursuing opinions from recommended companies;
 - Still working on West Entry step lighting;
 - Doors/security, the South interior door needs to be repaired, still looking into options.
