- o Landmarks Tour-Complete, About 130 people, steady flow. Great exposure for the Church.
- Man-lift/scaffolding-Looking into the feasibility of purchasing to be able to gain access to the hanging light fixtures in the Sanctuary. Checking with an electrical company named Maxwell, to see if they would have some ideas on repairing/updating to LED.
- Sound system AV needs in Fellowship Hall, John Hague schedule busy now. Hopefully after the season he will be able to bring his findings to the Trustees.
- Lactation Station (S. Galloway) chair, table, privacy cover, Amazon, upstairs women's rooms,
 \$500. J. Linnan to purchase, S. Galloway to assemble if needed.
